ADDISON COMMUNITY SCHOOLS
OPERATING MILLAGE RENEWAL PROPOSAL

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance. The remaining .6095 mill is only available to be levied to restore millage lost as a result of the reduction required by the “Headlee” amendment to the Michigan Constitution of 1963 and will only be levied to the extent necessary to restore that reduction.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Addison Community Schools, Lenawee, Hillsdale and Jackson Counties, Michigan, be renewed by 18.6095 mills (\$18.6095 on each \$1,000 of taxable valuation) for a period of 5 years, 2021 to 2025, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2021 is approximately \$3,390,210 (this is a renewal of millage that will expire with the 2020 tax levy)?

JACKSON COUNTY SENIOR CITIZENS SERVICES
MILLAGE PROPOSAL

For the purpose of continuing funding necessary to maintain services for senior citizens in Jackson County, shall the constitutional limitation upon the total amount of taxes which may be assessed in one (1) year upon all property within the County of Jackson, Michigan, be increased at a rate of up to 0.6 of one (1) mill (\$0.60 per \$1,000 of taxable value), for a period of ten (10) years (2020-2029) inclusive?

If approved and levied in full, this millage will raise an estimated \$2,861,273.54 in the first calendar year of the levy based on taxable value. If approved and levied, in accordance with State law a portion of the millage may be distributed to the Downtown Development Authorities of the City of Jackson, the Villages of Grass Lake and Springport, and the Townships of Blackman and Leoni; the Local Development Finance Authorities of the Village of Parma and the Township of Blackman; and the Brownfield Redevelopment Authority of the City of Jackson.

OPERATING MILLAGE RESTORATION PROPOSAL

This authorization will (i) restore the authority of Jackson Public Schools to levy 18.00 mills previously authorized and levied for general operating purposes on non-homestead taxable property (comprised primarily of business, commercial, and rental property) which has been reduced by .1080 mill by application of the Headlee Amendment, and (ii) increase the prior authority by 2.0000 mills to allow the School District to continue to levy 18 mills in the event of future Headlee rollbacks of up to the same amount. This authority, combined with the School District's unexpired authorization, would allow the School District to receive revenues at the full foundation allowance permitted by the State.

Shall the limitation on the amount of taxes which may be imposed on taxable non-homestead property in Jackson Public Schools, County of Jackson, State of Michigan, be increased by 2.1080 mills (\$2.1080 on each \$1,000 of taxable value) for six (6) years, the years 2020 to 2025, inclusive, to provide funds for operating expenses? This millage would raise an estimated \$55,000 for the school district in the first year that it is levied.

remodeling, furnishing and refurbishing, and equipping and re-equipping school facilities; erecting, furnishing, and equipping additions to the K-12 school building, including wood shop, auto shop, and home economics additions; erecting, furnishing, and equipping a restroom facility; purchasing school buses; and preparing, developing, improving, and equipping a running track, athletic fields, athletic facilities, a playground, and sites?
