## **MILLAGE RENEWAL PROPOSITION NO.1**

### **0.4617 MILL FOR FIRE PROTECTION PURPOSES**

Shall the expiring previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Columbia Township, of .5 mill (\$0.50 per \$1,000 of taxable value), reduced to .4617 mills (\$0.4617 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at .4617 mills (\$0.4617 per \$1,000 of taxable value) and levied for 5 years, 2012 through 2016, inclusive, to solely provide fire protection within Columbia Township, including the operation of the Columbia Township Fire Department, raising an estimated \$157.728 in the first year the millage is levied.

## **MILLAGE RENEWAL PROPOSITION NO.2**

### **0.9236 MILL FOR POLICE PROTECTION PURPOSES**

Shall the expiring previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Columbia Township, of 1 mill (\$1.00 per \$1,000 of taxable value), reduced to .9236 mills (\$0.9236 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at .9236 mills (\$0.9236 per \$1,000 of taxable value) and levied for 5 years, 2012 through 2016, inclusive, to solely provide police protection within Columbia Township, including the operation of the Columbia Township Police Department, raising an estimated \$315.557 in the first year the millage is levied.

SPECIAL EDUCATION MILLAGE PROPOSAL  
(RESTORATION OF HEADLEE REDUCTION)

This proposal will allow the intermediate school district to continue to levy special education millage previously approved by the electors and restores millage lost as a result of the "Headlee" reduction.

Shall the current charter limitation on the annual property tax rate previously approved by the electors of Jackson County Intermediate School District, Michigan, for the education of students with a disability be increased by 0.7736 mill (\$0.7736 on each \$1,000 of taxable valuation) for a period of 20 years, 2011 to 2030, inclusive (this increase will allow the intermediate school district to levy the rate of 5.5 mills previously approved by the electors which has been reduced as required by the Michigan Constitution of 1963); the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2011 is approximately \$3,365,000 from local property taxes authorized herein?
