On Sheet CS-101, it shows the fence posts for all of the 4'H. fence posts at 4' o.c., on Sheet CS-501, the fence schedule calls for the posts to be 6' o.c., both are super overkill, especially considering that the 8'H. fence posts are 8' o.c.  All of the fence posts should be 8' or 10' o.c.	The spacing of posts for the 4' high fence have been amended to 8' o.c. Please see updated plans for the fence layout in the CS-101 drawing plan attached with this Addendum.
